Notes regarding the maintenance contract:

The HOA board members have received questions from several residents regarding the scope of our maintenance contract with Piedmont Landscape and Irrigation LLC. An explanation as to why some open spaces (completely within our HOA) are not being maintained has also been sought. The following is an attempt to explain the situation and provide a reason for having agenda item-4.

Currently, we only have one contract which is on the behalf of (and paid for by) all Highlands subdivision neighborhoods for the maintenance of the common entrance (this includes mowing, edging, over-seeding, fertilizing, liming, "aerification" along the common entrance/exit streets and on both sides of the front entrance along the fences on route 240, planting annuals at the ends of the entrance/exit median, watering, mulching of all beds and around trees that line the entrance/exit streets, pruning shrubs and leaf and trash removal). We cannot include any of our "private" open areas in this contract because these costs are shared with other neighborhood home owners associations. Our HOA does not currently have any separate contract for the maintenance of "private" open areas completely within the detached home owners neighborhood (Highlands 1B). However, we can certainly consider having a new separate contract for the maintenance of such spaces if it is desirable and the costs are agreeable to all members of our HOA.
