Subject: Annual meeting, Current financial situation, Notice of HOA dues, etc.

Dear Highlands Detached Homeowner:

The annual meeting of the members of the Highlands Detached Home Owners Association was held at the Crozet Elementary School cafeteria on the 23rd of February 2006. Thanks to all of the residents who attended the session and provided useful suggestions. Please review the minutes* of the proceedings of this meeting enclosed with this letter.

As noted by the HOA president at the annual meeting, the Association is behind on its payments due to the extended absence and inaction of the previous secretary/treasurer. In order to rectify the situation, the HOA removed the secretary/treasurer and appointed a new treasurer. The bank required an authorization from the members of the association to transfer the funds from the existing account to a new account and release the funds. The HOA members present at the meeting granted such an authorization. A new account has since been set up, and we are working hard to catch up on missed payments. Furthermore, a review of the older accounts has revealed that the previous secretary/treasurer had misappropriated HOA funds to the tune of approximately \$10,000 (the exact amount involved is still a matter of investigation). The older accounts were accessible solely to this individual. The HOA president has contacted the local police in this regard, and we will hold another meeting of the HOA to discuss how to remedy the situation, and recover the funds as well as review the finances prior to the 23rd of February 2006. This meeting will be held on Thursday, the 30th of March 2006 at 7:00 PM at the Crozet Elementary School cafeteria. We are also working actively with the bank to help us piece together all of the financial transactions over the past few years. To prevent any gross abuse of this nature by any one individual in the future, the new board has separate individuals appointed to the position of the HOA president, secretary, and treasurer and new bank account has been set up to be accessible by both the HOA president and the treasurer, so that there is better oversight into its operation and balances.

More recently, we have also received notice from the Internal Revenue Service that the HOA has failed to file tax returns for the past three consecutive years (2002, 2003 and 2004), and has also not responded to its earlier notices. The HOA president has contacted the Internal Revenue Service as directed by this notice. We are working to file all of the past returns and pay the taxes, fines and penalties that are due at the present time. The tax return for 2005 is also due shortly.

The covenants require the association to collect dues from its members at the rate of \$4 per month (\$1 per month from owners of vacant lots). In the past, rather than collect the dues each month, the amount for the entire year was assessed at one time in the middle of

Thus the total annual amount of \$48 (\$12 for owners of vacant lots) will be due on the 30th of June 2006. Please remember to send in your payments by this date. Checks should be made payable to "Highlands Detached Home Owners Association". We encourage you to mail in your payments ahead of the due date to help shore up the funds in the operating account, and satisfy the associations' existing and long overdue financial obligations. The mailing address for sending the payment appears on the top of this letterhead.


We also request you to complete the name and address information on the HOA dues invoice and return it with the payment, so that we may update our records.
